## **VIII. NEW BUSINESS**

### **A. Discussion of Potential Additional Events for 2017**

Director Richmond summarized the Twilight Trail event that has taken place in recent years. She suggested that the low turnout last time may have been a timing issue. She stated that the event for 2017 will be called, "Tales and Trails" and that it incorporates the Storybook Trail. She stated that they will add a book with an animal theme and the activities would be centered around that theme. She summarized the registration for the event and added that they would work out the details. She stated that this event will more be visible than the event last year since it is utilizing the southern trail at the Shiawassee Basin Preserve. She suggested that if attendees choose, they can leave the Storybook Trail and extend their walk out to the Long Lake Overlook.

Commissioner Baker asked if there would be people along the trail out to the overlook.

Director Richmond answered that it would depend on how many volunteers they were able to get. They are trying to keep staff time down and utilize volunteers.

Chairperson Bower stated that he agrees with renaming the event and understands why it would be centered around dogs because dogs are frequent visitors to the trail.

Commissioner Vallad stated that she understands why they need to cut costs and suggested that it is a good idea to incorporate the Storybook Trail.

Commissioners discussed the use of the north and the south trail and the attendance at past events.

Commissioner Parke stated that he understands the budget and coordinating revenue with the library.

Commissioner Bower suggested that they hand out or display something showing the other trails. He offered to take pictures for the display.

Director Richmond stated that this event is being planned for Wednesday, June 21, 2017. She suggested that they can do the s'mores right over a grill, instead of a bonfire, because there are grills in the pavilion. She also suggested that they might be looking at getting character costumes.

Commissioner Christensen suggested having a pre-marketing event where if a resident "catches" a picture of their child reading outside and posts it, maybe they get a free ticket.

Director Richmond explained the Halloween event that was in her memo. They are still working on this event. She suggested a Friday and Saturday event that is centered around Halloween. She suggested that they have an escape room with a maze at the end of this that needs to be walked through. She summarized some ideas that the Department has come up with for the event and possible partnering with a local church. She stated that they might be making some changes to the Easter Egg Hunt event too. She summarized the Easter Egg Hunt from last year that was sold out but they lost money because of the building rental at Springfield Oaks even at a discounted rental rate. She suggested ways to hold the event this year that would be beneficial.

Commissioner Omell stated that he is in favor of having the event at Springfield Oaks, it is much safer.

Commissioners concurred.

Commissioners and Director Richmond suggested ways to make the timing more efficient for all children.

Commissioner Baker asked about the teen Halloween event. She suggested adding a magician because it would not take them long to get through the room and maze.

Director Richmond answered that this is a good idea, it may come down to the area that is available and whether or not they can utilize the partnership church property.

Commissioners suggested ideas for the teen maze.

Director Richmond stated that the Santa event may be changed after they receive survey results back from participants. They are still examining this event.
