Chief Feichtner described the honor, integrity and loyalty that the Fire Department embraces as their core values as he distributed the leather shields for their helmets.

Old Business:

1. Second Reading: Amend Code of Ordinances Chapter 40, Section ~~40-833~~ 40-883 – Noise and Section 40-2.

Supervisor Walls explained that this amendment is for provisions amending the Township's noise regulations within the Zoning Ordinance. Consultants were hired to ensure that the standards were current with their settings and the appropriate measuring equipment was necessary to measure. Terminology and decibel readings are the significant differences.

- * **Clerk Moreau moved to adopt amendments to the Code of Ordinances section 40-883 Noise and Section 40-2 Definitions as published for Second Reading. Amendments to take effect seven days following Notice of Adoption. Trustee Vallad supported the motion. Vote on the motion. Yes: Cooper, Dubre, Hensler, Hopper, Moreau, Vallad and Walls; No: none; absent: none. The motion carried by a 7 to 0 vote.**

2. Second Reading: Amend Code of Ordinance Chapter 40, Section 40-884 Vibration and Section 40-2

Supervisor Walls explained that, similar to the Noise amendment, the standards and definitions have been updated and represent current technology.

- * **Trustee Vallad moved to amend the Code of Ordinances Section 40-884 vibration of Article VI Environmental Performance and Section 40-2 Definitions to add appropriate definitions for vibration and related items as published for Second Reading, said amendments to take effect as prescribed by law following publication of Notice of Adoption. Trustee Cooper supported the motion. Vote on the motion. Yes: Cooper, Dubre, Hensler, Hopper, Moreau, Vallad and Walls; No: none; absent: none. The motion carried by a 7 to 0 vote.**

3. Second Reading: Request to rezone 9230 Dixie Highway, P.I. #07-14-430-032 to O-S Office Service from R-3 One Family Residential.

Supervisor Walls explained that there are three parcels up for rezoning, the first two are adjacent parcels, owned by different parties that are requested to be rezoned from Residential to Office-Service. The first of the two is a brick front building, previously used for office space. A public hearing has been held by the planning commission and approval was recommended.

- * **Clerk Moreau moved to rezone the half acre parcel at 9230 Dixie Highway, parcel ID # 07-14-430-032 to O-S Office Service from R-3 One Family Residential as published for Second Reading. Trustee Cooper supported the motion.**

Comments:

Thomas Wyler, 9171 Hillcrest asked about his rights to privacy, as his property is adjacent to the parcel in question.

Supervisor Walls replied that no site plan has been submitted but it should reflect the necessary screening requirements.

Mr. Wyler commented that a “for lease” sign is already posted.

Supervisor Walls replied that the sign is not a violation, but a site plan must be submitted.

Vote on the motion. Yes: Cooper, Dubre, Hensler, Hopper, Moreau, Vallad and Walls; No: none; absent: none. The motion carried by a 7 to 0 vote.

4. Second Reading: Request to rezone 9246 Dixie Highway, P.I. #07-14-430-031 to O-S Office Service from R-3 One Family Residential.

Supervisor Walls explained that the second of the two adjacent properties is vacant and has gone through the same planning commission process with the same approval recommendation.

5. Second Reading: Request to rezone parcels on Dixie Highway between I-75 and Bluewater Dr., P.I. #07-24-101-005 and #07-24-101-011 to C-2 General Business from R-3 One Family Residential.

Supervisor Walls explained that this request is to rezone from Residential to General Business. Jim Scharl, a representative of the applicant was present in the Board Meeting. The parcels in question previously were ball fields for Dixie Baptist Church and a children's daycare center/playground.

Trustee Vallad asked if the applicant would address the glare of the lights from the former Children's Ark building shining toward Dixie Highway.

Mr. Scharl replied that there has been some remodeling to that building and there are plans to use it as a storage building for a temporary basis. Mr. Scharl will indicate the light concerns to the owner.

- * **Trustee Vallad moved to approve the request by AJD Development of 8700 Dixie Highway, Clarkston to rezone two parcels totaling 21.6 acres located on the southwest side of Dixie Highway between Bluewater Drive and I-75 to C-2 General Business from R-3 One Family Residential; Property ID Numbers include #07-24-101-005 (19.27 acres) and #07-24-101-011 (2.33 acres). Clerk Moreau supported the motion.**

Comments:

Bob Gray, 9022 East Blue Water Drive asked about future meetings on this subject.

Supervisor Walls answered that there has not been a site plan submitted yet. The earliest it could be submitted is the September Planning Commission meeting.

Vote on the motion. Yes: Cooper, Dubre, Hensler, Hopper, Moreau, Vallad and Walls; No: none; absent: none. The motion carried by a 7 to 0 vote.



New Business:

1. First Reading: Amend Code of Ordinances Chapter 40-Zoning by adding new Section 40-597 Mineral Mining

Supervisor Walls explained that this amendment is an attempt to update the mining/extractive provisions to be more in conformance with changes in the State Law and current operating procedures in the mining industry. The plan is to move from a separate extractive zoning district for new applications to allowing mining to be considered as a special land use in low density residential, commercial, industrial and public land zoning districts. This amendment leaves current mining operations and current ordinance provisions in effect, establishes that new mining will be by special land use and includes specific requirements for applications and standards for both the applicant and the Township.

- * **Trustee Hopper moved to authorize the Clerk to publish for Second Reading amendments to the Springfield Township Code of Ordinances Section 40 Zoning by adding new Section 40-597 Mineral Mining to Article IV, Special Development Standards as presented. Trustee Hensler supported the motion. Vote on the motion. Yes: Cooper, Dubre, Hensler, Hopper, Moreau, Vallad and Walls; No: none; absent: none. The motion carried by a 7 to 0 vote.**

2. Waumegah Lake Special Assessment Refunding

Treasurer Dubre reported that one of the Waumegah Lake Board members contacted her about refunding the existing legal assessment and well funds assessment. Treasurer Dubre asked for Board member input regarding the amount of administrative fee that should be collected from the Lake Board for this refund. She reminded the Board that the only refund of assessments that the Township has administered was charged a fee of \$20,000. The Lake Board has two assessments that they would like refunded; the legal assessment and the well assessment, which were collected at different times.

Treasurer Dubre suggested an administrative fee of \$10,000, which is roughly 10%; approximately \$7,000 to the well account and approximately \$3,000 to the legal account, adjusting for bills paid.

There were no concerns from the Board concerning the amount to be charged.

Treasurer Dubre has asked that a draft resolution with rough amounts inserted be signed and returned from the Lake Board no later than the end of the month for attorney review before the Lake Board meeting on September 8, 2016. This would then be added to the Springfield Township Board Meeting to be reviewed in October to affirm the Lake Board's resolution and refunds can be dispersed on approximately October 13, 2016.

Time will be needed to calculate each individual refund, as not all will be equal, depending on location and lake access type.

Trustee Hopper questioned how this related to the community sewer escrow funding and if funds could be transferred into that account for the association.

Treasurer Dubre and Supervisor Walls both replied that that is not an option.

Trustee Vallad asked if separate checks need to be written for each parcel from the two different funds.

Treasurer Dubre stated that no, two checks were not going to be issued. The Legal was assessed in 2004-2008 and the well assessment was made 2002-2011. There were different assessments for access, canal and lakefront properties and some parcels were not developed when assessments were made. The Autumn Shores development was assessed as one parcel and then split into 10 lakefront properties and the assessment was split between all 10. She further explained that there will be much calculation required to determine the correct refund amount. One check will be issued with explanation of how each was determined.

Supervisor Walls commented that three or four different departments within the Township will have to work on these calculations.

Treasurer Dubre informed the Board that the Lake Association does have their own attorney which will aid in the communication with the Township attorney.

Trustee Vallad commented that the time span for the assessments is long.

Treasurer Dubre replied that the Township will only deal with the current owners of record. Further, the Lake Board's adopted resolution for refund has to be submitted to the Township by September 30, 2016 so that owners of record can be established and a firm amount can be established.



- * **Supervisor Walls moved to have the Township Board conditionally establish a fee of \$10,000 to process refunds of fund balances in the Waumegah Lake Board Well Assessment Fund and in the Waumegah Lake Board Legal Assessment Fund IF the Waumegah Lake Board provides a draft Resolution requesting the funds for review and approval by the Township Attorney no later than August 31, 2016; a \$10,000 fee to be divided and charged \$3,000 to the Legal Assessment Fund and \$7,000 to the Well Assessment Fund. In addition, the township agreement to the refund is conditioned on the Treasurer's receipt by September 30, 2016 of a Resolution approved and signed by the Waumegah Lake Board substantially the same as the draft reviewed and approved by the Township attorney requesting and authorizing the refunds. Trustee Vallad supported the motion. Vote on the motion. Yes: Cooper, Dubre, Hensler, Hopper, Moreau, Vallad and Walls; No: none; absent: none. The motion carried by a 7 to 0 vote.**

3. Lot Split Request – Lot 1, Supervisor's Plat 11

Supervisor Walls summarized the request to split 20 feet off of Lot 1 Supervisor's plat #11 and combine it with the adjacent plat #2, #3 and #4 of Supervisor's Plat #11. Actions should be subject to taxes being paid and the submittal of legal descriptions. He further explained that this is one of the most unusual areas of the township, as a school district divides a home. They cannot be combined due to old bond commitments.

Treasurer Dubre asked about timing of the development so that proper parcel numbers can be established.

Supervisor Walls replied that the builder has already asked for a permit.

Clerk Moreau asked if the extra 20 feet was necessary in order to build.

Supervisor Walls replied that it was necessary to allow room for the septic system.

Trustee Vallad asked for clarification that the applicant on this request was Ed O'Neil.



- * **Trustee Vallad moved approve the request of Ed O'Neil of 6825 Dixie Highway Suite C, Clarkston Michigan, 48346 to split the southerly 20 feet of lot #1 Supervisor's plat #11, parcel ID #07-11-152-001 and combine the split with adjacent parcel #07-11-152-011 which currently contains lots #2, #3 and #4 of Supervisor's plat #11, subject to current payment of all taxes, verification of surveys supplied and legal description. Trustee Hopper supported the motion. Vote on the motion. Yes: Cooper, Dubre, Hensler, Hopper, Moreau, Vallad and Walls; No: none; absent: none. The motion carried by a 7 to 0 vote.**

4. Lot Split – Lot 15, Supervisor's Plat 10

Supervisor Walls explained that the properties are on Bigelow Road and are proposed to be split with half of Lot 15 to be split and linked with lot #14, leaving part of Lot 15, lot 16 and lot 17 as a second parcel. Both parcels will exceed minimum lot area and provide required setback.

- * **Trustee Vallad moved to approve the request of Darrell Heard of 11060 70th Ave North, Seminole, Florida 33772, to split and combine Lots 14 and half of 15 of Supervisor's plat #10 from parcel ID #07-10-451-036 to create a new parcel and leaving half of Lot 15, lot 16 and 17 of Supervisor's plat #10 as part of the original parcel, subject to verification of taxes current and all legal description and survey. Trustee Hopper supported the motion.**

Treasurer Dubre asked about the timing of the building.

Mr. Darrell Heard, applicant, answered that he would move quickly.

Supervisor Walls explained that Mr. Heard would need to have paperwork filed by September 15, 2016.

Vote on the motion. Yes: Cooper, Dubre, Hensler, Hopper, Moreau, Vallad and Walls; No: none; absent: none. The motion carried by a 7 to 0 vote.

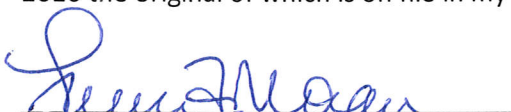

**RESOLUTION IN OPPOSITION TO THE
REGIONAL TRANSIT AUTHORITY PLAN AND MILLAGE**

WHEREAS, the Charter Township of Springfield ("Township") opposes the Regional Transit Authority of Southeast Michigan (RTA) 1.2 mill, 20 year property tax increase to create a mass transit system that does not connect with or benefit the Township; and

WHEREAS, the Township opposes the RTA Master Plan because it only benefits a select few communities in Oakland County; and

WHEREAS, the Township is opposed to the RTA because impacted communities cannot opt out and, therefore, the Township may be taxed for two (2) transportation authorities; and

WHEREAS, the Township opposes RTA's 1.2 mill proposal as the tax is excessive, punitive and 20% more than the most recent Township General Fund operating millage; and

WHEREAS, the RTA Master Plan does not provide reasonable local service at any time in the 20 year period; and

WHEREAS, the RTA Millage will be in addition to SMART and other transit millage paid by many communities within the region; and

WHEREAS, the Township proposes that RTA fiscally improve the current Regional Transportation systems prior to initiating new or increased millage for a new system; and

WHEREAS, the vast majority of Township residents mode of transportation will remain using their individual vehicles receiving no benefit from the RTA plan or tax; and

WHEREAS, recent agreements by members of the authority have improved administration of the tax and plan it did not insure equitable service for all proportional to the tax burden.


NOW, THEREFORE, BE IT RESOLVED, the Charter Township of Springfield Board approved this resolution in opposition to the RTA's proposed Plan and 1.2 mill tax and directs the Clerk to forward a copy of this resolution to our Oakland County Commissioner, State Representatives, and to the Chairperson of the RTA.
