Director Tucker stated that it is part of the grant that the department has received from the U.S. Department of Agriculture-Natural Resource Conservation Service. She also stated that she would like to have a portion of this project completed before the prescribed burn season.

# E. Playworld PVC Free Pledge Grant Opportunity

The Park Commission discussed the memo from Director Tucker detailing the grant opportunity.

The department would be eligible for up to \$ 25,000.00 in funds from the grant with a \$10,000.00 match.

Director Tucker stated she had discussed this matter with Township Supervisor Trout, who is amicable to this opportunity. If the Park Commission approved pursuing this opportunity Director Tucker would have to go to the Township Board to seek the \$ 10,000.00 matching funds due to the fact that the Parks Fund Budget is very constrained.

Commissioner Zemon-Parker asked where the structure would be placed.

Director Tucker stated it would be placed in the southern portion of the Shiawassee Basin Preserve.

Commissioner Vallad moved that Director Tucker pursue the opportunity for a PVC Free Playstructure through the Playworld Pledge Grant contingent upon the matching funds coming from the Township Board.
