V. PUBLIC COMMENT

Clerk Strole informed the Park Commission that the Township Board had tabled the budget amendment dated August 12, 2008 at their October 9, 2008 meeting. Clerk Strole stated that the amendment was not tabled due to any deficiencies in the proposed budget amendment but rather because the majority of the board wanted an explanation of the actions leading up to the amendment. Clerk Strole stated that this issue will once again be on the Township Board agenda for approval in November.

Clerk Strole also stated that she would like to personally thank the Park Commission members for their service and she appreciates them and all of their hard work.

Clerk Strole also informed the Commission that she and Director Tucker had met with a representative of the Shiawassee Wildlife Refuge Management and took him out to see the

beginning of the Shiawassee River. The gentleman seemed very impressed by the quality of the area.

Clerk Strole also stated that she believes that there needs to be an easy access to the Shiawassee Basin Preserve on the north side of the train tracks so that people can see how great the area is. She stated that it is her belief that people will take ownership and pride in the area and they will want to help preserve the area. Clerk Strole said that at the Davis Lake entrance she would like to see bollards installed by the gate area to make it easier for park patrons to access this parcel of the park.

A. Approval to Seek Community Development Block Grant Funds

Director Tucker stated that she is seeking permission to request money from the Community Development Block Grant Funds.

Director Tucker indicated that there was a possibility that there would be funds available for an accessible boat launch at the Mill Pond Park, if applicable, and Phase II of the Invasive Plant Management Plan.

Director Tucker stated that the Township Board would be discussing the awarding of these funds at their November meeting.

Commissioner Hyer moved to accept Director Tucker's request to seek CDBG Funds for an accessible boat launch, Phase II of the Invasive Plant Management Plan, and other applicable projects per her memo dated October 6, 2008. Commissioner Hyer was supported by Commissioner Hudson. Vote on the motion: Yes: Baker, Hudson Hyer, Parke, and Vallad; No: LaLone; Absent: Zemon-Parker. The motion carried by a 5-1 vote.

Commissioner LaLone did not feel that the boat launch was a good idea at this time and was not worth Director Tucker's time to work on it.

B. Additional Fencing for the Shiawassee Basin Preserve

Director Tucker informed the Commission that the northern boundary from Eaton Road to Long Lake has been completed. Director Tucker stated that there is a small portion on the northwest side of the lake that needs to be completed and the fall or winter would be the best time to complete it.

The Commission discussed which of the high priority areas had the fencing completed and which areas still needed to be fenced. At this time out of the four sections that were contracted for the survey, two sections had been completed.

Chairperson Parke moved to have Director Tucker look into the price to have fencing completed for the west side of Eaton road south of the Trail Head, the northern tip and the northern and eastern part of the gravel pit. Chairperson Parke was supported by Commissioner LaLone. Vote on the motion: Yes: Baker, Hudson Hyer, LaLone, Parke, and Vallad; No: None; Absent: Zemon-Parker. The motion carried by a 6-0 vote.

C. Press Conference for U.S. Department of Agriculture Natural Resource Conservation Service Reimbursement Program on October 24, 2008
