Commissioners and Mr. Lewan reviewed his memo dated April 12, 2019 and the amendments presented for Section 40-2 addition of "Food Truck" and addition of Section 40-651 – Food Truck Regulation.

Mr. Lewan indicated that he would add zoning categories like Village Center-VC to the proposed ordinance language and he would also make any changes necessary to reflect the signage ordinance changes that the Township Board is working on now to make the new language consistent. He will bring this item back to the Commission next month for their review.
