#### VII. OLD BUSINESS

# A. Approval of Regular Meeting Minutes-May 8, 2007

The Commission discussed the May 8, 2007 meeting minutes and made a few corrections to them.

Commissioner Vallad moved to accept the May 8, 2007 meeting minutes as revised. Commissioner Vallad was supported by Commissioner Zemon-Parker. The motion carried by a 7-0 vote.

#### VIII. NEW BUSINESS

#### A. 2008 Budget

Commissioner Vallad stated that she had e-mailed the Township Board members regarding the budget process for 2008 on June 7, 2007 and she had not received any response from any of the members. Commissioner Vallad stated that she was disappointed in the lack of response.

The Commission members looked over the 2008 draft budget notes and made some comparisons to the 2007 budget. Several suggestions were made for the next draft of the budget, which would be presented at the July 10, 2007 Park Commission meeting.

# B. Approval of Hiring Jessica Parke

Chairperson Parke requested permission to abstain from voting on this matter since Jessica Parke is his daughter.

Commissioner Vallad moved to grant Chairperson Parke permission to abstain on the voting for the Approval of Hiring Jessica Parke. Commissioner Vallad was supported by Commissioner Baker. Vote on the motion: Yes: Baker, Hudson, Hyer, LaLone, Zemon-Parker, and Vallad. No: None. Abstaining: Parke. The motion carried by 6-0 vote.

Commissioner Hyer moved to approve the hiring of Jessica Parke. Commissioner Hyer was supported by Commissioner Zemon-Parker. Vote on the motion: Yes: Baker, Hudson, Hyer, LaLone, Zemon-Parker, and Vallad. No: None. Abstaining: Parke. The motion carried by 6-0 vote.

#### IX. TREASURER'S REPORT

#### A. Bills List

Commissioner Vallad moved to approve payment of the bills as follows: Parks and Recreation at \$ 112,009.35 and Trust and Agency \$ 1,100.00. Commissioner Vallad was supported by Commissioner LaLone. The motion carried by a 7-0 vote.

# **B. Budget Amendment**

Chairperson Parke stated that he had contacted the Township Board members to notify them that the Mill Pond Park Parking Lot Reconstruction Project would be over the \$60,000.00 that was originally budgeted for this project but should not exceed \$65,000.00. However, due to the additional cost for having to comply with the Oakland County Road Commission requirement of nine inches of deep strength asphalt at the driveway entry, the project final cost is \$69,413.50.

Commissioner Vallad moved to accept the budget amendment as presented. Commissioner Vallad was supported by Commissioner Baker. The motion carried by a 7-0 vote.

#### XII. COMMISSIONER COMMENT

Commissioner LaLone informed the Commission that on August 28, 2007 the Ride Rose event would take place. At this event horseback riders ride from Rose Oaks in Rose Township to Springfield Oaks in Springfield Township.

Commissioner LaLone stated that she was very discouraged that her husband Mike LaLone of Mike LaLone Well Service, Inc. has not heard anything about the drinking fountain that he recently donated and installed at the Shiawassee Basin Preserve athletic fields.

Director Tucker stated that a thank you and an in-kind form had already been sent to Mr. LaLone but in addition she had another letter from the Park Commission that she would be sending him after it is signed after the meeting. Also it is her understanding from staff that is present at the games at those athletic fields that patrons seem very appreciative of having the newly installed drinking fountain.

Commissioner Hudson inquired how the fencing along the railroad was coming.

Director Tucker stated that the fencing has been purchased and now it just needed to be delivered out there and the installation process would begin soon.

Commissioner Hudson also informed Director Tucker that he has come to a dead end in trying to find a solution to the muck problem at Mill Pond Park. Commissioner Hudson was informed by the DNR that there is an enzyme that could be used that would not be harmful to environment but they stated that he would have to contact the Department of Environmental Quality. Commissioner Hudson stated that he is now passing all the information onto Director Tucker for her to continue following up on.

Commissioner Baker congratulated Commissioner Hyer who was awarded the "New Professional" award through the Michigan Recreation Park Association.
