Approval of Agenda:

Vice Chairperson Steckling asked to hold Mr. Need's presentation to the end of agenda. The Board concurred.

Public Comment:

Mr. Jim Roll, General Council for the Jesuits commented regarding Colombiere and Shepherd's Hollow, that they are concerned about the proposal to rezone. They would like the zoning left as it is. Mr. Roll asked for notices to be sent to certain individuals. He was told to contact the Clerk for notice arrangements.

Unfinished Business:

1. Ordinance No. 27, Subdivision Ordinance

Mr. Greg Need, Township Attorney, explained that he reviewed the proposed revisions to Ordinance No. 27. He provided comments in written form dated November 28, 2006.

He explained that the Land Division Act is clear in stating that requirements are minimum requirements and the community can enact higher standards. He believes the Township could incorporate their site plan standards into the subdivision ordinance but does not think they automatically apply. The ordinance would need amending. He believes it is defensible but cannot guarantee that because there is ambiguity in the statute and in the way the courts have interpreted the statute.

Vice Chairperson Steckling asked how this would be different from a normal site plan if we incorporate those provisions by reference? Mr. Need said, it is more defensible to have a separate, stand-alone ordinance as we have now rather than just putting all subdivisions into the zoning ordinance for review and process.

Commissioner Baker said on item 2 (a), new wording is suggested that would appear in 3.02 1d. He asked Mr. Need if he is planning to preserve the first sentence as it exists now in 3.02 1d and then put the rest after it? Mr. Need said, yes.

Supervisor Walls said the last page indicates Section 3.06 4 and asked why it should be in that section? Mr. Need explained that that was the section that deals with failure to complete improvements but it does not have to be there. It could be a separate sub-section 5. Supervisor Walls asked if it should be at the very beginning? Mr. Need said it could be in the application section just as easily. Ms. Elmiger said she would change it as a separate sub-section 5. Supervisor Walls asked regarding the fee, does the Land Division Act require more explanation? Mr. Need said no. Supervisor Walls suggested adding "and an administrative fee of 25%." Mr. Need said that would cover it.

Commissioner Hines said Section 3.06 1 says that construction of all improvement should be approved by the Township Board prior to final plat approval. She asked for clarification. Mr. Need explained that is the process that takes place in terms of the construction sequence.

Commissioner Champion asked regarding item 4 (b), how should the inconsistency be addressed? Mr. Need said the language should be the same in both. The statute says that the

surveyor has to prepare the preliminary plan but the additional language that allows other kinds of plans to be submitted can be included, although the plat itself has to be prepared by a surveyor.

Commissioner Hines asked regarding Section 3.02 1 d, language is proposed that the Clerk would not accept the application if it is not complete. However, in Section 5 a 2, it says the Township planner and engineer should check the proposed plat for completeness. She asked why would a planner or engineer get an incomplete plat? Mr. Need said at that point, there should not be an incomplete application. Commissioner Hines asked if section 3 should say "the Township Planner and Engineer within 10 business days of receipt of a complete preliminary plat?" Mr. Need said, yes.

The Planning Commission agreed they would like to be involved in these changes even though they are not statutorily required to be. It was unanimous that they would like to review the changes made before a public hearing.

Ms. Elmiger said she would make the proposed changes and bring them back to the Planning Commission for their review.

Commissioner Hines suggested throughout the document being consistent and stating "tentative preliminary plat." The Planning Commission agreed. Ms. Elmiger said she would make the necessary changes.

Supervisor Walls suggested changing the numbering for better flow.

New Business:
